

CUSTODIAN TRUST DEED

THIS DEED is dated

in its/their capacity as trustee(s) of
ABC Superannuation Fund
("Beneficiary")

BACKGROUND

- A. The Beneficiary intends to acquire the beneficial interest in the property described in the Schedule annexed ("Asset") with the legal title to that Asset being acquired and held by the Custodian as trustee for the Beneficiary.
- B. The Beneficiary will provide the purchase money for the Asset.

OPERATIVE PROVISIONS

1 TRUST

- 1.1 The Custodian declares the trusts contained in this Deed.
- 1.2 The Custodian acknowledges that the Custodian will acquire the Asset and will hold the Asset upon trust for the Beneficiary absolutely and to this end will enter in an agreement for the purchase of the Asset.
- 1.3 Nothing in this Deed entitles the Custodian to a beneficial interest in the Asset.

2 NAME OF THE TRUST

This Trust may be known as the SMSF Borrowing Trust or such other name or without a name as the Beneficiary notifies the Custodian in writing from time to time.

3 CUSTODIAN TO OBEY DIRECTIONS OF BENEFICIARY

The Custodian must deal with the Asset as the Beneficiary directs.

4 VARIATION

This Deed may be amended by deed executed by the Beneficiary, notice in writing of which is to be given to the Custodian.

5 CUSTODIAN

5.1 Custodian means the trustee of this Trust from time to time.

5.2 The Beneficiary may remove the Custodian of this Trust from time to time and appoint a replacement to be the trustee of this Trust by notice in writing given to the Custodian to be removed.

6 HEADINGS

Headings to clauses are included for the sake of convenience only and will not affect the meaning of the clauses to which they relate.

7 NOTICES

7.1 A notice or other communication required or permitted to be given by one party to another must be in writing and:

- (a) Delivered personally;
- (b) Sent by pre-paid mail to the address of the addressee specified in this Deed; or
- (c) Sent by facsimile transmission to the facsimile number of the addressee with acknowledgment of receipt from the facsimile machine of the addressee.

7.2 A notice or other communication is taken to have been given (unless otherwise proved):

- (a) if mailed, on the second business day after posting; or
- (b) if sent by facsimile before 4 pm on a business day at the place of receipt, on the day it is sent and otherwise on the next business day at the place of receipt.

7.3 A party may change its address for service by giving notice of that change in writing to the other parties.

8 GOVERNING LAW AND JURISDICTION

8.1 This Deed is governed by the laws of the State of Queensland.

8.2 Each party irrevocably submits to the non-exclusive jurisdiction of the courts of the State of Queensland.

9 FURTHER ASSURANCE

Each party will from time to time do all things (including executing all documents) necessary or desirable to give full effect to this Deed.

10 RIGHT TO ACQUIRE LEGAL OWNERSHIP

The Beneficiary will make one or more payments in respect of its borrowings on the Asset before requiring a transfer of the legal title to the Beneficiary.

11 INDEMNITY

Any right of indemnity of the Custodian against the Beneficiary is limited to the extent required by section 67A Superannuation Industry (Supervision) Act 1993 (Cth), if necessary to comply with that section.
